Submission Process

1. Read and accept the Submission Agreement below.
2. Fill in the fields in the submission form.
3. Upload a copy of your narrative to the repository.
4. Click "Submit."

Upon completion of this process, you will receive an email confirming your submission.

Submission Agreement

To effectively administer works submitted to the Athenaeum, the University of the Incarnate Word Libraries need certain permissions to be granted by the copyright holder(s) or appropriate licensee(s) of such works.
